When the context so requires, the masculine includes the feminine and or neuter, and the singular

Conduit, in this hold harmless and indemnity agreement the term conduit signifies a means of transmitting and distributing energy and the effects/produce of labour, such as goods and services, via the name :dash;©, any and all derivatives and variations in the spelling of said names except :dash;©.

Creditor, in this hold harmless and indemnity agreement the term creditor means :dash;©

Juristic person, in this hold harmless and indemnity agreement the term juristic person means an abstract legal entity Ens Legis, such as a corporation, by construct of law and considered as possessing certain legal rights of a human being; an imaginary entity such as a debtor, i.e. DASH LALONDE©, which on the basis of legal reasoning is legally treated as a human being for the purpose of conducting commercial activity for the benefit of a biological living being such a creditor.
